Incomplete applications will **NOT** be accepted.

Application Completion:

- 1. Complete all sections of the application.
- 2. Attach a copy of any and all completed inspection reports.
- 3. Attach a copy of any license applications (i.e. DHS application).
- 4. Attach photographs.
- 5. Written statement explaining the training and experience of the applicant and center staff.

Frequently Asked Application Questions:

- 1. Photographs: (please include the following when submitting pictures)
 - Exterior of structure
 - · Parking areas
 - Outdooor play area
 - · Each interior room
 - Signage
- 2. Written Statement:
 - Include copies of all pertinent certifications.
- 3. Costs:
 - \$100 fee for City of Del City Child Care License per year.

*Any lapse in licensure will require resubmission of all documents and may require a new Special Use Permit (if required) and new Certificate of Occupancy.

A copy of the current city code and zoning regulations regarding child care centers is available on request. The following are important points to consider (but are not exhaustive):

- Home Child Care centers are subject to special regulations, including but not limited to;
 - o Home Child Care Centers may **ONLY** be located in the primary residence of the property owner.
 - Home Child Care Centers may NOT have exterior signage.
- Fencing for Outdoor play areas **MUST** be:
 - o Surrounded by an opaque ornamental fence
 - o Chain link fencing will only be permitted if it is the black vinyl-coated type and is in good repair
 - o Stockade fencing must meet the requirement of being "ornamental"
 - o Vinyl fencing is generally permissible
 - Metal panel fencing is generally <u>NOT</u> acceptable.
- Structures and yards must be in good condition and must not present a hazard to children.
