All applications must be completed in full, including all required supporting documentation. Incomplete applications will NOT be accepted.

Be sure to read these instructions carefully before proceeding

Required Documents

- Attach a copy of any and all completed inspection reports.
- Attach a copy of any license application (i.e. DHS application).
- Attach written statement explaining the training and experience of the applicant and center staff, along with copies of certifications/licenses.
- Please include the following when submitting pictures:

• Costs: \$100 fee for City of Del City Child Care. License shall expire on the last day of June after they are issued. The renewal grace period will be July 1-August 1 of each calendar year. Renewal licenses submitted after grace period are subject to a \$100 late fee.

Any laps in licensure will require resubmission of all documents and may require a new Specific Use Permit (if required) and new certificate of occupancy.

A copy of the current city code and zoning regulations regarding child care centers is available upon request. The following are important points to consider (but are not limited to):

- Home Child Care centers are subject to special regulations, including but not limited to:
 - o Home Child Care Centers may only be located in the primary residence of the property owner
 - Home Child Care Centers may not have exterior signage
- Fencing and Outdoor play areas must be:
 - Surrounded by an opaque ornamental fence.
 - o Chain link fencing will only be permitted if it is the black vinyl-coated type and is in good repair.
 - Stockade fencing must meet the requirment of being "ornamental".
 - Vinyl fencing is generally permissible.
 - o Metal panel fencing is generally not acceptable.
- Structures and yards must be in good condition and must not present a hazard to children.
