- City Manager JD Hock said that the General Fund, which is the 01 account will be taking \$1 million from the DCMSA and borrowing \$500,000 from the Neighborhood Fund which is fun d35 to be able to be fiscally connected. The goal is to either change revenue streams or take other steps so that the general fund does not have to borrow from other funds. The revenue numbers that City Manager Hock presented are based off an average of the 3 previous fiscal years. The figures show that revenues is up between 0-2% and operational costs have increased up to 20%. He also said that the city is looking to change revenue and cut expenses where we can.
- Mayor Eason said he would like to call attention to the fact that we are borrowing from ourselves. This is money that is in one fund being shifted to another. He does not want anyone to get the impression that Del City is in a financial crisis. This is an inherited problem, and we are moving forward with correcting the issues.
- Councilwoman Finch said that she is glad that the funds are finally being used correctly.
- Councilman Tatom said thank you to the City Manager, Assistant City Manager and Staff for getting this going in the right direction.

1. Discussion Only – Fines and Ordinances

Discussion only regarding the issue of fines and ordinances.

- Mayor Eason spoke about the cost comparison sheet of our fines vs other cities in the metro that Police Chief Berger put together and Mayor feels like we the fines and ordinances need to be updated. Does not want to be known as a speed trap town but does want the streets to be safe for our kids. The mayor said we are just having a discussion on how to stop the speeding and running the stop signs from happening. He said he can't tell them to go out and write tickets but wants to know if there's any other way to get people's attention on it. Wants it to be a cooperative effort between the police department and the judicial system and for the judges to get some guidance and not be so lenient in the courtroom.
- City Manager JD Hock mentioned that the state legislature passed a law that anyone that had a municipal ticket can prove financial hardship then they are able to have that ticket dismissed and there have been multiple people that have taken advantage of that. This may be something that needs to be brought up to our two state legislatures about how this law is a hindrance to hold people accountable for breaking the law. Mayor Eason is interested in ideas for alternative sentencing as well as a minimum fine amount allowed so that when they go to court the judge can't give them a low fine amount because then that takes the teeth out of it. Wants people to know not to go to Del City and speed or run stop signs because it will cost you.
- Councilman Tatom agreed with Mayor and City Manager and would like to hear from the Chief or any police officers on this and asked the Chief his opinion on raising fines.
- Councilwoman Browne wants as much information as possible on this. Said that there is
 an opportunity here to review reports and see what offenses and areas are the most
 affected before we immediately raise the fees. Also said that it's unfortunate that this
 conversation is happening at budget time due to optics and we don't want this to be the
 way that we beef up our budget.
- Police Chief Berger said that he heard that Councilwoman Browne is to head up our traffic committee. These problems are a nationwide problem and aren't just in Del City. Announced that he is open to any suggestions on how we can reduce traffic issues because he doesn't know the true answer. We do have motor officers out this summer for an extra presence.
- Mayor Eason asked if there is anything out there like flock cameras for traffic? Chief Berger doesn't believe that it is an avenue to pursue right now due to so many issues

- with it. There is a grant coming up to pay overtime for officers for traffic enforcement and believes there is a need for it.
- Councilwoman Finch would like to see the comparison chart of our fines vs other metro cities. Also likes the idea of community service for offsetting fines.
- Walter Jacques 4832 Koelsh Dr. said that in other countries they have a financial model based on income. Not sure if that would violate Title 21 Oklahoma statute, but in general a ticket amount would be based off of how much income someone had. This may also prevent the city from having to constantly revise the ordinances.
- Joshua Schultz 4321 Spiva Dr. wondered if maybe there can be a set range on the fines so they aren't too little of an amount or too much. Robert Manger the chair of the Judiciary Committee would be a good person to talk to on this. Also raising fines with each repeated offense may be a good idea as well.
