#### 3. PUBLIC AND COMMITTEE INPUT

- a. Commissioner McTrusty submitted a "desert type" landscape for potential usage in City Hall flower bed or other city buildings. This concept is like what OnCue did at I-35 and Grand Blvd. McTrusty also submitted "chalk type" drawing styles that are used on brick. Styles include positive statements, warm greetings, and pleasant shapes. These could be implemented on the brick buildings around Olde Towne, 29th/Vickie, and Liberty Tax was used as an example.

  - vi. The Community Garden at Rotary Park needs the sprinkler system to activate around 3:00am and run for at least 20 minutes due to the heat.
